

- (a) Fire call to residences, farms, commercial and industrial establishments. The costs and expenses of fire calls to residences, farms, commercial and residential establishments shall be billed by the Hatley Area Fire & Ambulance District jointly to the property owner(s) and/or occupant(s) and paid to the Hatley Area Fire and Ambulance District Treasurer with ninety (90) days of the date of billing. Bills remaining outstanding, including interest, for more than ninety (90) days as of November 1 of any year shall become a lien against the real estate for which the fire protection was provided and shall be placed on the tax roll as a delinquent special charge pursuant to sec. 66.0627, Wis. Stats.
- (b) Other fire call charges. The actual costs and expenses incurred by the Hatley Area Fire and Ambulance District for fire service to the scene of a motor vehicle, truck, or equipment accident shall be billed by the Hatley Area Fire and Ambulance District to the person or persons who have been served by the fire call. Payment shall be made without interest if paid within ninety (90) days from the date of billing.

SECTION 2: All ordinances and parts of ordinances in conflict herewith are hereby repealed.

SECTION 3: This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
